### VOTING RIGHTS AT THE 139TH ANNUAL COMMUNICATION

Beginning with the 139th Session, "Credential Cards" will no longer be issued. However, you MUST present your current Dues/Membership Card and have a photo ID when you sign in for session. Proxy Cards have been mailed to the Lodges for the WM, SW and JW who are unable to attend.

Brothers and Sisters,

I was not going to get involved in this discussion in the Montana Stars but felt it was necessary to clear up some items that were printed on this site.

As the notification of the meeting stated, the vote, dealing with the Masonic Home, will be held following discussion that is scheduled for the Masonic Home Corporation meeting on June 24, 2005 at 1:15 PM at the Holiday Inn at 5 Baxter Lane in Bozeman, Montana. It went out to all Lodges in the Legislation Packets.

Discussion will be controlled by the Brothers and their willingness to share additional factual information. Pro and Con speakers will be kept as a side for side presentation until such time as no additional factual information is being shared or if items presented begin repeating themselves, then it will cease and a vote will follow. Of course, as in all Masonic meetings, the discussion must remain cordial and respectful or discussion will stop. This means there could be one speaker for each side or 20 for each side but the conduct and material of the presenters will control that.

It is my duty to keep this vote fair and on the level and I assure you I am doing my best to make that happen.

I assured all Masons they would have, or have access to, factual information and in time for them to look at both sides and have an opportunity to endeavor to understand the reasoning for each, whether for or against the recommendation. I did not feel it was fair to have Brothers come to the Grand Communication and receive the study report information in their packets, then that afternoon be expected to vote on such a major issue as this. So I ordered the information to be distributed to all of the members and others. That way a vote could be had that was fair and voters could cast a knowledgeable vote for whichever side they elected to do so and could feel that they had cast a vote they would not question after having cast it.

Unfortunately, some Masons have put out false statements about the coming vote, hopefully not knowing they were false. While most Masons will be able to sort out the truths from the untruths, there may be some who will be misled. This serves neither the Craft nor the Home.

Just a reminder, one of the many things that makes this fraternity stand out among men is something that is stated very well in the Entered Apprentice Lecture and I quote, "*Truth is a divine attribute and the foundation of every virtue. To be good and true is the first lesson we are taught in Masonry. On this theme we contemplate, and by its dictates endeavor to regulate our conduct. Hence while influenced by this principle, hypocrisy and deceit are unknown among us, sincerity and plain dealing distinguish us, and the heart and tongue join in promoting each other's welfare and rejoicing in each other's prosperity.*" That is what Masons are reminded of in all of their thoughts, words and actions. I would ask my Brother Masons as well my Sisters of the OES to assist us all by sharing only truthful information, so the Masons will not have to worry about breaking one of the three great tenets of a Mason's profession when they repeat what they heard or read, in this publication or elsewhere. I would ask all to be sure of the truthfulness of any statement you make, spread, or publish.

Untruths don't help anyone, including the one that voiced them, and simple rumors that are being spread are not within the tenets of the Masonic Family and cause the vote to be unfair to both, the voters and the Home, not to mention the credibility of the Masonic Family.

## GRAND REPRESENTATIVE REPORTS

By direction of the MWGM and in accordance with Code Section 11010. GRAND REPRESENTATIVES must attend Montana Grand Lodge Communications, communicate with the Grand Jurisdiction represented, and make a written report to the Grand Secretary no later than April 30 each year as to the contents of communications exchanged with the Grand Jurisdiction represented. There are several current Grand Representatives who are in danger of losing their commission for not complying with Code Section 11010. The Grand Master will be making recommendations to continue or discontinue commissions issued by other jurisdictions.

### BIKES FOR BOOKS

In order to receive the 50% matching funds up \$400.00 from the Montana Masonic Foundation you must submit your receipts to the Grand Secretary by 1 June 2005. Those received after 30 June will not be processed.

So far 33 Lodges have reported in as participating in the Bikes for Books program, resulting in 263 bikes being awarded in 104 schools across the State. The following is a list of those Lodges identified as participating:

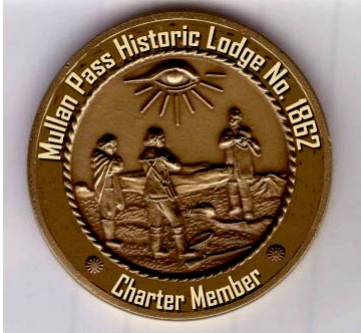
### LIMITED EDITION PRINT

### LODGE ELECTIONS

Lodge elections are required by Code Section 25020 to be held between the first regular meeting in May and the first regular meeting in June.

In accordance with Code Section 27030, service as Warden in any Jurisdiction renders the member eligible to election as Master. All the officers, except the Tyler, must be chosen from among the members of the Lodge. No one shall be eligible to office who is not in good standing and who has not passed a satisfactory examination for proficiency in all three Degrees.

**25030. INSTALLATION.** Lodges shall hold their annual installation of officers after the annual communication of Grand Lodge, but no later than the first regular meeting in September, and hold their offices until their successors are elected and installed.
