Section 10030 of the Code of Statutes states that Montana Master Masons who have performed eminent and outstanding service to Montana Masonry as well as having contributed to the growth of their community, state or the United States may be elected to the Montana Masonic Hail of Fame.

Membership shall be by nomination from constituent lodges. This award program shall be administered as provided for by Grand Lodge in 1986. See Administrative Procedures.

If your lodge is nominating a member to the Hall of Fame, complete the APPLICATION - NOMINATION FORM on the reverse side; use the completed form as the cover of your booklet of substantiating evidence of worthiness and endorsements by Brothers and Citizens.

Master Masons nominated may be living or deceased; if decease they must have been in good standing at the time of death.

# Mail nominations BEFORE APRIL 1, 2006 of the year nomination is to be considered:

1. April 1- Grand Historian will receive nominations <u>only</u> at the Grand Lodge Helena address.

2. April 10- Grand Historian transmits nominations to Hall of Fame Trustees for review, consideration and balloting.

3. June 1- Trustees' ballots returned to Grand Historian,

4. June 10- Grand Historian tabulates votes; submits results and name(s) of Brothers) elected to the Most Worshipful Grand Master. *Note: Name(s) shall not be announced prior to Annual Communications and then only when instructed by M. W. Grand Master.* 

5. Certificate(s) honoring the member(s) sleeted will be prepared by Grand Lodge and presented to the recipient, his Lodge and family.

#### **RESOLUTION FORMAT**

#### **RESOLUTION DRAFTING INSTRUCTIONS**

These instructions provide the accepted protocol on formatting and styling to be used in drafting resolutions for Grand Lodge legislation for its deliberation at annual communications. Resolutions not submitted in accordance with these instructions will be returned to the submitting lodge for re-drafting, or reformatting by the Jurisprudence Committee.

The formatting and drafting requirements are as follows:

1. The heading is "Resolution No.\_\_\_\_\_

2. A resolution may only contain one subject which is clearly stated in its title.

3. The title of the resolution is placed under the heading with a double spaced separation. The title must state concisely what the resolution proposes to do. If the resolution proposes amending a section of the Constitution or the Code, the section must be stated in the title.

4. The resolution may not contain any recitals or whereas clauses within the resolution. A detailed argument and explanation for the resolution may be set forth on a separate page attached to the resolution, which is entitled "Proponent's Explanation of Resolution for [title of Resolution]. The proponent's explanation may not exceed one page, single spaced, with no smaller than 11 point type. It may be written in outline or narrative form. It is recommended that the explanation briefly explain the present situation or status quo and should explain how the proposed resolution improves or corrects the present situation. If the explanation exceeds one page in length, additional pages beyond the first page will not be sent out to the lodges with the resolution and will be destroyed.

5. The resolution portion must read "Be it resolved that:" Each amended section will be in a sequentially numbered paragraph that reads: "Section\_\_\_\_\_\_of the [Constitution or Code] be amended as follows:" Each new section will likewise be in a sequentially numbered paragraph that reads: "New Section of the [Constitution or Code] be enacted as follows:"

6. If a section is proposed to be amended, the entire section must be included in the body of the resolution. Additions of text to a section are shown by underline and if desired may be also in bold font or italicized. In any case additions must be underlined. Deletions of text are shown by strikethrough. Either single or double strikethrough may be used, though single is preferable. Be sure to use underlines for added punctuation and strikethroughs to delete unnecessary punctuation. Also note that underlines and strikethroughs are used to add or delete paragraph letters or numbers.

7. When a new section is proposed, even though a new number may be proposed for the section, the Grand Secretary, as codifier, will assign a number to the section.

8. When a section is amended or a new section is proposed, check other sections in both the Code and Constitution that be affected by the amendment or new section. These sections must be amended in the resolution by setting forth the entire section, with additions by underline and deletions by strikethrough.

These Resolution Drafting Instructions were adopted 6 day of December 2003, by order of the Most Worshipful Grand Master of the Grand Lodge of Ancient, Free and Accepted Masons of Montana, and are for use in submission of resolutions at the 2006 Annual Communication.

## TIDBIT FOR FEBRUARY 2006 THE LESSER LIGHTS

The symbolic use of the three lesser lights is very old, being found in the earliest written lectures of the Masonic fraternity back to the early eighteenth century. The use of lights in religious ceremonies is an ancient custom. and burning tapers were always typical of moral, spiritual, or intellectual light. The three lesser lights in our **Masonic Lodges refer to the** Sun the Moon and the Master of the Lodge. They are represented by three burning tapers placed in a triangular position in the Lodge. The custom in some Grand **Jurisdictions like Montana is** to place the burning tapers, or three lesser lights, in a triangular position to the south of the altar. In other Jurisdictions they are found burning on or beside the pedestals of the Master and the Wardens. Some Grand Lodges require that the lights be placed on both sides of the altar two on one side and one on the other.

When a candidate is brought to light during the degrees, the lights of the room should be extinguished or dimmed very low and only the three lesser lights lit to aid the **Brother in seeing the three** Great Lights before him. This is observed because of our ritual on page 30 lines 21 and 22, which says "The three Great Lights of Masonry by the aid of the representatives of the three lesser." Also, this is a much kinder way to come to light!

## **REQUIRED FOR NEW MASTER MASONS**

Section 25040 of the code requires that – the MONITOR (Section 2 of the Montana Masonic Manual) and the **COACH'S HANDBOOK be** presented to every Master Mason. Lodges shall present to each brother, at the time he receives the third degree, a copy of the official Monitor of this jurisdiction and a copy of the Montana Coach's Handbook. These are available from the Grand Lodge Office. The Monitor is \$7.50 and the Coach's Handbook is \$1.00, plus postage.

## ADVISED FOR ALL LODGE OFFICER'S

All officers of the Lodge should have a copy of the Montana Masonic Manual, current copy of the Constitution and Code of Statutes of the Grand Lodge AF&AM of Montana and a copy of the Lodge By Laws. These are available from the Grand Lodge Office, the Montana Masonic Manual is \$16.50 and the Constitution and Code of Statutes is \$5.00.

IF GOING TO ALL THE WAY IN ONE OR TWO DAYS CLASS, COLLECT LODGE DUES AND SEE WHAT OTHER BODIES HE NEEDS PETITIONS FOR AND GET THEM FOR HIM 8 ASK IF HE HAS A MENTOR HE WANTS AND RESPECTS OR
