#### Grand Master's Americanism Observance Message

#### THE AMERICAN WAY – SOMETHING TO BE CHERISHED AND PROTECTED

A reporter took a ride in a taxi in Baghdad in an attempt to see first hand what life for Iraqi civilians was really like. Shortly after he left his secure hotel, he began having second thoughts. The taxi driver was weaving in and out of traffic like a crazy man, and the reporter began to fear for his safety. When the driver raced through a relatively busy intersection without stopping at a stop sign, the reporter had had enough. He asked the driver if he was driving so fast because of security reasons. The driver laughed and answered, "Oh no, it's safe in this area. But we have freedom in Iraq now. In Saddam's day, I would always follow the traffic laws. If I didn't, I would be arrested, taken to jail, and beaten. Now, they don't beat us any more, so why follow the laws? They just slow us down. Isn't democracy wonderful?" [*Taken from a blog on the internet.*]

I am not sure if the above story is true. But the next story is true. Three years ago, my wife and I vacationed in the Czech Republic. In Prague, our tour group passed through a once-beautiful neighborhood that was defaced by a lot of graffiti on the walls and trash strewn all over the sidewalk. Our tour guide apologized for the condition of the streets. She commented that one effect of the "Velvet Revolution", the bloodless overthrow of the communist government, was that many young people now believe that freedom means they are free from all laws and can do whatever they want, regardless of the result. The government, not wanting to be compared with its oppressive communist predecessor, refused to enforce "minor" laws. Thus, in Prague and other Czech cities, trash in the streets, graffiti and pickpockets in public places are common.

A characteristic of American society is that most of us realize that freedom cannot be

enjoyed without responsibility, and rights are always accompanied by corresponding duties. Yes, some American drivers are reckless. Yes, there is a lot of trash in some areas. But on the whole, Americans have much more respect for their responsibilities and duties. Freedom of speech is tempered with a responsibility to keep the contents of our speech truthful. Our right to practice our religion without restriction is accompanied by a duty to allow others who do not share our beliefs to practice their religion with the same freedom we have.

After the American presidential election in 2000, Al Gore appealed to both state and federal courts claiming alleged irregularities in the Florida vote count, to include miscounting the infamous "hanging chads", but after the courts ruled against him, Mr. Gore conceded the presidency to George W. Bush. Did Mr. Gore incite his supporters to riot in the streets? Of course not! After the 2006 elections, the Republicans peacefully turned over the power of the majority in Congress to the Democrats. Was there grumbling? Yes. Was there bickering? Yes. Did the supporters of the Republicans riot or use violent means to prevent the take over of power by the Democrats? Again, of course not! That is not the American way. Compare these transfers of power in the White House and Congress with the recent presidential election in Mexico. The losing candidate cried "Fraud", and called on his supporters to demonstrate (riot?) in the capital city in an attempt to disrupt the city and shut down the government, even after the courts ruled against him. The lesson here is that the vast majority of American citizens realize that our freedom to have differing political opinions is accompanied by a duty to respect the will of the majority and the rulings of established courts. What happened in Mexico would be unthinkable in the United States.

## THE LEVEL

Another extremely important American cultural and political principle is the principle of subordination of military forces to civilian control. As a result of this principle, the most powerful military force in the world has always subordinated itself to the elected civilian Commander-in-Chief. The coup, that military operation that seems so common in other countries of the world, has never threatened the American government. Unlike other militaries, the American Armed Forces are respected and honored, rather than feared, by the citizens of this great nation.

Freedoms and responsibilities, rights and duties are inseparable combinations in the American political tradition. We truly cannot have one without the other.

As we conduct our Americanism observances in our Lodges, we should all be proud that many of our American ideals and concepts are also Masonic ideals and concepts. When the Constitution of the United States was written in 1787, monarchs ruled all European governments. There may have been parliaments to advise the monarchs, but generally, the monarchs' powers were absolute. In addition, membership in almost all of the parliaments was at least partially, and often totally, hereditary.

Contrast the usual system of government in the 18th Century with our Lodges and Grand Lodges. The Masters and Wardens of a Lodge are elected by the membership. The Master and Wardens or their proxies, along with the Secretary, represent their Lodge as the voting power of Grand Lodge, both for passing legislation and electing Grand Lodge officers. The structure has the power flowing from the members of Lodge up to the Master and Wardens, and through them, to Grand Lodge. Power flowed from the bottom up, not from the top down as in the governments of Europe at that time. WHAT A NOVEL AND REVOLUTIONARY CONCEPT! The Grand Lodge system was first laid out in Anderson's Constitutions of 1723, 64 years before the US Constitution was written in 1787.

Under the US Constitution, we have states with republican forms of government. The citizens of the states elect congressmen and senators to represent us in Washington. The people elect Electors, who in turn elect the President. Thus, like a Masonic Lodge and Grand Lodge, power flows up from the people, not downward as in the governments of 18<sup>th</sup> Century Europe. The structure looks very much like that specified by Anderson's Constitutions. The fact that there were 13 Masons among the 39 signers of the Constitution, including Brothers George Washington and Benjamin Franklin, probably had something to do with the similarities.

Each of us should thank the Great Architect of the Universe every day for giving us the blessings of living in this great nation. We should be proud of our American heritage, and of the contribution Masons have made to that heritage. And finally, we should ever be mindful of the duties and responsibilities that we owe to our great nation so it may be protected and preserved.

## GRAND MASTER'S CLASSES FOR 2007

The "Request for Conferral of Degrees" form for each candidate must be in the hands of the Grand Secretary not later than twenty-one days prior to the scheduled class. If there are not twelve or more confirmed candidates by the deadline, the class will be cancelled.

1. All candidates must have received the Entered Apprentice degree in their lodge or in another lodge by courtesy work, and have passed proficiency in the first degree, prior to coming to the Grand Master's class. Only the Fellowcraft and Master Mason degrees will be conferred during the Grand Master's classes during February, March and May.
2. For the April Grand Master's Class the above restrictions are not applicable. The "Request for Conferral of Degrees" form still must be in the hands of the Grand Secretary not later than twenty-one days prior to the class.

However, there will be no minimum number of candidates for the April class; this class will be conducted regardless of the number of candidates. In addition, the Entered Apprentice Degree will be conferred in this class.

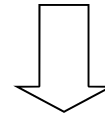
Worshipful Masters ensure that a mentor accompanies each of their candidates. The role of mentor is extremely important, and using a total stranger from another lodge as mentor takes away much of the bonding that is necessary for the candidate to feel welcome and at ease. Finally, please inform all members of your Lodge that appropriate attire for candidates, mentors, and sideliners is coat and tie.

### **RESOLUTION FORMAT** **RESOLUTION DRAFTING INSTRUCTIONS**

These instructions provide the accepted protocol on formatting and styling to be used in drafting resolutions for Grand Lodge legislation for its deliberation at annual communications. Resolutions not submitted in accordance with these instructions will be returned to the submitting lodge for re-drafting, or reformatting by the Jurisprudence Committee.

The formatting and drafting requirements are as follows:

1. The heading is "Resolution No. \_\_\_\_\_."
2. A resolution may only contain one subject which is clearly stated in its title.
3. The title of the resolution is placed under the heading with a double spaced separation. The title must state concisely what the resolution proposes to do. If the resolution proposes amending a section of the Constitution or the Code, the section must be stated in the title.
4. The resolution may not contain any recitals or whereas clauses within the resolution. A detailed argument and explanation for the resolution may be set forth on a separate page attached to the resolution, which is entitled "Proponent's Explanation of Resolution for [title of Resolution]. The proponent's explanation may not exceed one page, single spaced, with no smaller than 11 point type. It may be written in outline or narrative form. It is recommended that the explanation briefly explain the present situation or status quo and should explain how the proposed resolution improves or corrects the present situation. If the explanation exceeds one page in length, additional pages beyond the first page will not be sent out to the lodges with the resolution and will be destroyed.
5. The resolution portion must read "Be it resolved that:" Each amended section will be in a sequentially numbered paragraph that reads: "Section \_\_\_\_ of the [Constitution or Code] be amended as follows:" Each new section will likewise be in a sequentially numbered paragraph that reads: "New Section of the [Constitution or Code] be enacted as follows:"
6. If a section is proposed to be amended, the entire section must be included in the body of the resolution. Additions of text to a section are shown by underline and if desired may be also in bold font or italicized. In any case additions must be underlined. Deletions of text are shown by strikethrough. Either single or double strikethrough may be used, though single is preferable. Be sure to use underlines for added punctuation and strikethroughs to delete unnecessary punctuation. Also note that underlines and strikethroughs are used to add or delete paragraph letters or numbers.

7. When a new section is proposed, even though a new number may be proposed for the section, the Grand Secretary, as codifier, will assign a number to the section.

8. When a section is amended or a new section is proposed, check other sections in both the Code and Constitution that be affected by the amendment or new section. These sections must be amended in the resolution by setting forth the entire section, with additions by underline and deletions by strikethrough.

These Resolution Drafting Instructions were adopted 6 day of December 2003, by order of the Most Worshipful Grand Master of the Grand Lodge of Ancient, Free and Accepted Masons of Montana, and are for use in submission of resolutions at the 2007 Annual Communication. Please include both a paper copy and an electronic copy of proposed legislation.

## HALL OF FAME NOMINATIONS

APPLICATION/NOMINATION FORM to be used to nominate a Master Mason to the Montana Masonic Hall of Fame are contained within your Lodge Assistance Package or contact the Grand Secretary.

Section 10030 of the Code of Statutes states that Montana Master Masons who have performed eminent and outstanding service to Montana Masonry as well as having contributed to the growth of their community, state or the United States may be elected to the Montana Masonic Hail of Fame.

Membership shall be by nomination from constituent lodges. This award program shall be administered as provided for by Grand Lodge in 1986. See Administrative Procedures.

If your lodge is nominating a member to the Hall of Fame, complete the APPLICATION - NOMINATION FORM; use the completed form as the cover of your booklet of substantiating evidence of worthiness and endorsements by Brothers and Citizens.

Master Masons nominated may be living or deceased; if decease they must have been in good standing at the time of death.
