

Most Worshipful Brother Paul E. Bovee was born July 1, 1931 in Delta, Colorado, the son of Eugene P. and Zadie E. Bovee. He was educated in Denver, graduating from West High in 1949. He attended Colorado State University and Denver University. He worked as an Engineer for many years as manager of planning, design and construction for Mountain Bell. On May 28, 1954, Brother Bovee married Mary Lou Kaufman. Most Worshipful Brother Paul is survived by his two daughters Lorena and Yvonne and several grand children.

Most Worshipful Brother Bovee was raised to the sublime degree of a Master Mason on April 22, 1956 in King Solomon's Lodge No. 9, Helena, Montana as a courtesy to Schiller Lodge no. 41 of Denver. Brother Bovee dimitted to King Solomon's No. 9 in 1957 and became its Worshipful Master in 1967 after serving as Lodge Instructor for six years. In Addition, he served on the following Grand Lodge Committees: Committee on Work, Scholarship Committee, Bulletin and Publication Committee and the Insurance Committee. Grand Master Richard B. Rule appointed Brother Bovee to the Grand Lodge line in 1974 as Grand Tyler.

Brother Bovee also belonged to the Scottish Rite, York Rite and Algeria Shrine and Miriam Chapter of the Order of the Eastern Star. He was an active member of the DeMolay Legion of Honor and served as the DeMolay Executive Officer.

Brother Bovee served in the United States Marine Corps during the Korean War. He was Past Secretary and Past President of the Optimist; a member of the American Society of Heating, Refrigeration and Air Conditioning Engineers, and was certified by the U.S. Government as a Fallout Radiation Analyst.

Most Worshipful Brother Donald W. Schenck, Past Grand Master - Honorary and Past Grand Secretary, installed Brother Paul E. Bovee into the office of Grand Master during the 119th Annual Communication.

Masonic graveside services for Most Worshipful Brother Paul E. Bovee will be held in Helena the specifict date is still being determined but will b July. More information will be provided as it becomes available.
